29 July 2022 - 21 September 2022

1. Introduction

- 1.1. This promotional competition ("**Competition**") is run by The South African Breweries (Pty) Ltd ("**Promoter**") and is open to all persons of 18 years or older and resident in South Africa, except for (a) the directors, members, partners, agents, consultants or employees of the Promoter and their immediate families, (b) the directors, members, partners, agents, consultants or employees of any suppliers of any goods or services to the Promoter in respect of this Competition, (c) directors, members, partners, agents, consultants or employees of the Promoter's advertising and promotion agencies or associated companies, and (d) participating outlet owners and staff.
- 1.2. The rules set out in this document constitute the rules which will govern the Competition ("**Competition Rules**").
- 1.3. Participation in the Competition by all entrants ("**Participants**") constitutes acceptance of these Competition Rules.

2. Competition Period

This Competition will run from 29 July 2022 until 21 September 2022, both dates being inclusive, or until the Promoter provides a public notice that the Competition has ended, whichever is earlier ("**Competition Period**"). Entries will only be accepted during the Competition Period.

3. Competition Entry Process

- 3.1. This Competition will take place online on the official Castle Lager website at www.castlelager.co.za.
- 3.2. Internet access is required to enter the Competition.
- 3.3. In order to enter the Competition, a Participant must register and sign up to the official website of the Promoter via the link www.castlelager.co.za. Participants will be required to provide the following information in order to register: (i) name; (ii) surname; (iii) date of birth; (iv) gender; (v) province they are resident in; (vi) cell phone number; (vii) favourite past time or hobby; and (viii) favourite occasion to enjoy a Castle Lager. The Promoter will provide a list of options for the Participants to select their favourite past time or hobby and their favourite occasion.
- 3.4. Once a Participant has successfully completed the sign-up and registration process in accordance with Competition Rule 3.3 above, a Participant will be entered into the Competition.
- 3.5. Entry is only valid through the above mediums and in the above manner.

- 3.6. A Participant can only enter the Competition once. One registration will amount to one entry into the Competition.
- 3.7. Participants are liable for their own data and voice charges in respect of the Competition participation as well as any verification process, if applicable.

4. Description of Prize

4.1. The prize for each winner in this Competition is one ticket for the winner and one ticket for a guest (2 tickets in total) to attend and watch one match forming part of the official Castle Lager Rugby Championships matches, scheduled to take place (i) on 6 August 2022 against New Zealand at Mbombela Stadium in Nelspruit ; (ii) 13 August 2022 against New Zealand at Emirates Airline Park in Johannesburg or (iii) 24 September 2022 against Argentina at Hollywoodbets Kings Park Stadium in Durban (the "Prize").

4.2. There are 75 Prizes available to be won during Competition Period as follows:

- 4.2.1. 25 Prizes to be won for the attendance of the match scheduled for 6 August 2022 against New Zealand at Mbombela Stadium in Nelspruit;
- 4.2.2. 25 prizes Prizes to be won for the attendance of the match scheduled for 13 August 2022 against New Zealand at Emirates Airline Park in Johannesburg and
- 4.2.3. 25 Prizes to be won for the attendance of the match scheduled for 24 September 2022 against Argentina at Hollywoodbets Kings Park Stadium in Durban;

4.3. Each Prize has a total value of approximately R500, with a total value for the Prizes of R37 500.

4.4. The Promoter will not pay for the travel costs of the winners or their guests. All winners and guests are responsible for making their own travel arrangements to receive and enjoy the Prize.

4.5. The winner and his/her guests must be available to attend the match related to the Prize on the date confirmed by the Promoter, failing which, the Promoter would be entitled to select a substitute winner.

4.6. Winners and their guests will be required to strictly observe Covid-19 protocols at all times while attending the match, in compliance with the Regulations.

4.7. No person may win more than one Prize in this Competition.

4.8. The winner may not transfer the Prize, in whole or in part, to any other person or exchange the Prize for an alternate prize or for its cash value. A winner may not substitute him/herself with any other person.

- 4.9. The Promoter will send the Prize to the winner electronically on or before the dates referred to in Competition Rule 5.1.

5. Winner Selection and Notification

- 5.1. The winners will be selected by the Promoter via 3 random draw processes. The draws will take place on or before the following dates: (i) 3 August 2022; (ii) 10 August 2022; and (iii) 21 September 2022 and will consist of all valid entries received during the Competition Periods.
- 5.2. 25 winners will be selected during each of the random draws and the Promoter will announce the winners on the same dates referred to in Competition Rule 5.1 above.
- 5.3. If the Promoter is unable to contact a winner, he/she will be disqualified and a substitute winner may at the discretion of the Promoter be selected, using the same winner selection process.

6. Winner Verification

- 6.1. The winners of a Prize and their guest/s (as applicable) that will receive the benefit of the Prize must: (i) be over the age of 18 years old; (ii) not be a director, member, partner, agent, consultant or employee of the Promoter and their immediate families; (iii) not be a director, member, partner, agent, consultant or employee of any supplier of any goods or services to the Promoter in respect of this Competition; (iv) not be a director, member, partner, agent, consultant or employee of the Promoter's advertising and promotion agencies, associated companies; (v) not be a participating outlet owner or staff member; and (vi) be fully vaccinated against Covid-19. The winners and guests may be asked to provide (and if asked, shall provide) confirmation of their vaccinations against Covid-19, which can be obtained at <https://vaccine.certificate.health.gov.za>, as well as a copy of their identity document/passport/driver's license/proof of residential address in order to receive the Prize.
- 6.2. A Prize will only be awarded after successful verification of a Participant who receives a Prize. Failing successful verification of a Participant, a substitute a Participant may be selected to win a prize at the discretion of the Promoter.
- 6.3. The Promoter reserves the right to carry out audits in respect of a Participant who receives a Prize to verify his/her eligibility and/or the validity of a Participant's entry. The Promoter may disqualify a Participant who receives a Prize if any fraud or cheating or related activity is suspected, including without limitation, through the manipulation of an entry or otherwise falsifying data. Should the Promoter or its agent determine that an entry or Participant is invalid or ineligible, the relevant Participant shall not be entitled to receive a Prize and will not be compensated in any way.

7. Prize Forfeiture

- 7.1. A winner must communicate his/her full details to the Promoter or its agent as requested by the Promoter or its agent. Failure to do so may result in forfeiture of a Prize.
- 7.2. If a winner is unable to attend, receive or utilise (as applicable) a Prize then the entire Prize shall be forfeited. There will be no compensation, in any form, including, but not limited to monetary compensation and/or rescheduling, to any party, irrespective of the reason/s for the inability of that winner to attend, receive or utilise (as applicable) a Prize.
- 7.3. Time permitting and subject to the Promoter's approval, where a Prize is forfeited a substitute winner may be chosen in the same manner as an original winner was chosen.

8. General

- 8.1. All Participants must comply with the Regulations at all times, and any non-compliance with the Regulations will result in automatic disqualification. It shall be the sole responsibility of the Participants to observe and comply with any and all restrictions imposed by the Regulations from time to time. Each Participant indemnifies and hold harmless the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and its associated companies, against any losses or damages arising from a breach of the provisions of the Regulations by such Participant, and the Promoter shall not in any manner whatsoever be liable for any transgressions by any Participant in this regard.
- 8.2. Should the process for entry into the Competition or the Prize/s involve any alcoholic beverage, Participants shall ensure that it is enjoyed responsibly.
- 8.3. In the event of a dispute, the Promoter's decision is final and binding and no correspondence will be entered into.
- 8.4. The timelines stated by the Promoter or its agent must be adhered to. Failing adherence to any timeline, at any stage, may result in disqualification and forfeiture of a Prize in its entirety with no compensation to any party by the Promoter.
- 8.5. Each Participant, by participating in the Competition, acknowledges, agrees and expressly consents to:
 - 8.5.1. the Promotor processing the Participant's personal information, including in the form of names, telephone numbers, identity numbers and/or email addresses, during and after the course and scope of the Competition; and

- 8.5.2. the Promotor transferring the winning Participant's personal information, including names, telephone numbers, identity numbers and/or email addresses, to the relevant third parties in order to make any required travel, delivery or other arrangements, as may be applicable, during the course and scope of the Competition for utilisation of a Prize,
- which processing and transfer shall take place in accordance with the provisions of the Protection of Personal Information Act 14 of 2013 ("POPIA") and any other applicable law, and for the purpose of giving effect to the Competition.
- 8.6. With the exception of Competition Rule 8.5 above, the Promoter will not share any personal information with any third party except where such disclosure is necessary to enable the Promoter to provide, deliver or in any other way give effect to these Competition Rules and/or the Prize, where such disclosure is permitted by law and/or where consent to sharing personal information is obtained from the relevant Participant by the Promoter. The Promoter will comply with the relevant data protection legislation, including POPIA.
- 8.7. A Participant may submit a request at <https://www.sab.co.za/content/data-subject-request-0> for the Promoter to:
- 8.7.1. correct or delete personal information about the Participant in the Promoter's possession or under its control that is inaccurate, irrelevant, excessive, out of date, incomplete, misleading or obtained unlawfully; or
- 8.7.2. destroy or delete a record of personal information about the Participant that the Promoter is no longer authorised to retain.
- 8.8. The Promoter may make media announcements containing, or otherwise publish, the names and/or photographs of a winner without remuneration being payable to the winner, provided that the Promoter will not do so if a winner communicates in writing to the Promoter that he/she does not want his or her names or photographs to be contained in media announcements or otherwise published.
- 8.9. Should a Prize not be available despite the Promoter's reasonable endeavours to procure the Prize, the Promoter reserves the right to substitute the Prize with another of equal value as determined in the Promoter's sole discretion and subject to availability. No person will be entitled to be compensated in any way in this instance by the Promoter.
- 8.10. The Promoter will not be responsible for any costs, expenses or other liabilities incurred by a winner which are not expressly contemplated as part of a Prize.

- 8.11. These Competition Rules may be amended by the Promoter on public notice at any time during the Competition Period or thereafter. These Competition Rules will be interpreted by the Promoter only.
- 8.12. The Promoter reserves the right to alter, amend or cancel this Competition in whole or in part. Any alterations, amendments or cancellations will be interpreted by the Promoter only. In the event of an alteration, amendment and/or cancellation, the Promoter will not compensate any individual for any reason whatsoever.
- 8.13. **Each Participant indemnifies and holds harmless the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and its associated companies, against any and all claims for any loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever connected to or arising out of his/her participation in any way in this Competition or his/her receipt, participation, ownership and/or use of a Prize. This indemnity is not intended to exclude any liability for any person which cannot be excluded under the Consumer Protection Act 68 of 2008.**
- 8.14. The Promoter shall not be responsible for any lost, damaged, corrupted, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending an entry will not be accepted as proof of receipt of such entry. The Promoter shall not be responsible for the failure of any technical element relating to this Competition that may result in an entry not being successfully submitted. The Promoter is not responsible for lost, damaged or delayed entries as a result of any network, computer or cell phone hardware or software failure of any kind. No entry from an agent, third party, organized group or entry automatically generated by computer will be valid or accepted. An entry will only be valid and accepted if it complies with all entry instructions and requirements. Any form of network or systems manipulation, including but not limited to Botnets, Sim Farms, Trojans, SMS malware may not be used when entering the Competition.
- 8.15. By participating in the Competition, each Participant gives the Promoter consent to: (i) market its products and campaigns to the Participant; (ii) conduct market research using personal information of the Participant which may be shared with third parties to enable the Promoter to develop appropriate marketing strategies in respect of its customers; and (iii) use the personal information and other details provided by the Participant during the Competition entry process for the purposes of facilitation of the Competition. A Participant may decline to provide or retract his/her consent by opting out via the opt out mechanism provided on the communications of the Promoter.
